- Gillian Angrove and Chantelle Coulson, Crown Prosecutors, from the Federal Prosecution Services provided a very informative session updating us on their project to refer alternatives to prosecution in Crown files, described as a "radical departure".
- the project was adopted in Feb '23
- number of files is increasing and access to files is expanding
- internal and external factors as well as barriers were presented
- · realize funding is a big issue
- working with 61 RJ organizations and IJP building connections
- some resistance from investigating partners
- · the process to review files was outlined
- encouraging start to this project
