#### 11:30 AM **Updates from Members**

Deanna (CCRJS)asked the group for feedback on how to generate RCMP referrals when you are a new program?

Loraine (Alberni) updates include efforts to develop more Youth focus and engaging the youth. They are also beginning a 5 session Strategic Planning process. Jan Slakov (Powell River ) Jan poses the question to the group" What can we do about decolonizing?"

Molly (Alert Bay) updates their program is responding to youth classes and realizes, like speaker Helen has said, it needs a "wrap around" approach.

David (S Gulf Islands) tells us they are in the rotational year for the RCMP so lots of networking to do. Using "Peace of the Circle" Training has been very helpful in many ways and in generating community conversations, using Zoom at times and has initiated requests from the community, victim services. For RJ week they are creating posters to be put up in the community each with a RJ story and theme. (A request was sent to members to submit a story about youth and RJ to be used in this campaign)

Jan Smalley (Sunshine Coast) says they are working on funding projects, making connections involving Truth and Reconciliation related situations and are focused on RJ youth in Schools.

Thanks were expressed for the topic and speakers provided by the Education Committee. The poll results showed a very favourable response to the speakers and topic. Kya was thanked for her assistance in tech support.
